#### ANNUAL FEMINISTAS UNIDAS MEETING

With approximately 30 members in attendance, President Stacey Schlau called the business meeting to order at 6:45 p.m., Saturday, December 29, 1991, at the Feministas Unidas suite at the San Francisco Marriott. The order of business was to first discuss the three proposals for organizational changes printed in the December '91 Newsletter which President Stacey Schlau had presented. Proposals I (a program selection committee) and III (a scholarship fund for needy members who wish to attend MLA) passed by almost unanimous votes. The middle proposal, Proposal II, establishing an intermediate organizational structure made up of regional representatives and caucus representatives, was certainly the most DISCUSSION-PRODUCING. Ultimately, the decision was made to appoint a task force to pursue this structure and make recommendations. However, the following letter from Stacey updates our membership on this important issue:

Dear Members of Feministas Unidas:

I hope all is going well for you this semester.

This letter is mainly an update on the results of the discussion about and voting on the three proposed changes. At the Feministas Unidas meeting at MLA in San Francisco, the minutes of which are on another page of this newsletter, the first and third changes in the organization (sent to you in the December newsletter with a ballot) were almost unanimously accepted. (The meeting was very well-attended, by the way.) The mail balloting confirms this acceptance unanimously. The first change establishes a procedure for electing a program committee for each MLA, to which interested members would submit proposals for sessions or papers. The third sets up a scholarship fund for needy members to help with expenses for attending the MLA meeting. The two have already begun to be implemented.

There was, however, a great deal of concern at the meeting, and mixed reactions in the mail votes, about whether the second, which suggested establishing an intermediate organizational structure (between elected officers and members), made up of representatives from regions and caucuses, was necessary and useful. At the meeting, the final agreement was to pursue this structure, but because the mail ballots were mixed I have not yet begun to organize this change. Of course, I received only thirteen, that's right thirteen responses through the mail, so I don't know if this mixed reaction--eight for, five against--is representative of the sentiments of the membership. Therefore, I am requesting that as many people as see fit fill out the new attached ballot regarding this change (besides those who already have--thank you) and write any comments you have on the same page. I don't feel we can proceed at this point without further input.

#### PROPOSAL

# REGIONAL REPRESENTATIVES AND CAUCUSES

#### Rationale:

There is little formal ongoing communication in the organization. With increasing budget constraints, especially at public universities, and a worsened economic situation in general, fewer members of Feministas Unidas will be able to attend the MLA meetings. The national structure is primarily maintained through the Newsletter, which, although it is eminently useful, in and of itself is not enough. No face-to-face person-to-person contact is possible except at the MLA or informally, as the organization currently works. Paying more attention to regional contact would build a stronger national organization, because people would have a chance to interact more about common concerns. If the regional caucuses were included in the national governing structure, people on a grassroots level might feel even more a part of the organization.

#### Change:

I propose that we: 1) set up some kind of regional caucuses or network systems. They would meet occasionally, generate their own (less elaborate and shorter) newsletter, or just serve as forum for people in the area. Each area (e.g., Southeast and Mid-Atlantic, Northeast, Midwest, South, West) would designate two convenors or representatives to the national organization as liaisons; 2) select or elect a task force, to write a report recommending how to set up regional structures (using regional MLAs as bases?), including what they might look like (even if informal), what they might do, their relationship to the national organization, etc.; 3) redefine a steering committee which might meet by conference call during the year, but would certainly meet before or after the membership meeting at MLA annually, that would include special interest groups within the organization, such as hispanas, lesbians, and regional caucuses; and 4) appoint a task force, which would include at least one liaison from the regional task force, to recommend a revised governing structure based on the above changes.

N. B. Perhaps the two task forces might be one, with subcommittees working on different aspects of the prospectus.

First is Integrating Latin American and Caribbean Women into the Curriculum and Research, a resource volume edited by Edna Acosta-Belén and Christine E. Bose of the University at Albany. The volume includes articles on the status of women's research and scholarship across the disciplines, curriculum transformation strategies, and sample course syllabi. chilla, Elsa Chaney, Margarite Fernández-Olmos, Gladys Jiménez, Asunción Lavrin, and Lynn Stephen. The publication of this volume is a joint effort of IROW and CELAC of the University at Albany, the Latin American Studies Association (LASA) Task Force on Women, and the Red Universitaria de Estudios de la Mujer en America Latina y el Caribe.

The second volume is the Albany PR-WOMENET Bibliographic Data Base on Puerto Rican women, edited by Edna Acosta-Belén and Christine Bose, with Anne Roschelle, and was funded in part by a grant from the New York State/United University Professions Joint Labor Management Committee on Affirmative Action. This reference volume provides annotated citations on the available research on Puerto Rican women published in both English and Spanish and includes over 600 citations. Sources are arranged

both alphabetically and by topic, and there is a key word index as well.

The third volume is An Interdisciplinary Guide for Research and Curriculum Development on Pucrlo Rican Women, compiled by Edna Acosta-Belén, Christine Bose, and Barbara Sjostrom. The guide contains information on issues, strategies, and priorities for integrating race, class, and gender, or specific content on Puerto Rican women into Humanities and Social Science curriculum or research proposals. 

Dr. Luz Maria Umpierre, Chair and Professor at S.U.N.Y./Brockport, presented a paper at the Modern Language Convention in San Francisco on "Oral Narrative as Subversion in the <u>Kiss of the Spider Woman</u> by Manuel Puig." The paper was co-authored with Dr.-Ellen J. Stekert of the University of Minnesota. Umpierre also presided over the discussion group on Puerto Rican Literature and Culture and participated in the Delegate Assembly as an elected member for Special Interests. She has helped increase the awareness toward the rights of the disabled to participate in the convention.

Umpierre had her testimony entitled "The Double L" published last month by Press Gang Publishers in Canada. The article has received wide praise since it narrates her poetical/political trajectory. Governor Jim Florio, of New Jersey, has congratulated Umpierre on the publication, which covers her trying years as an open Lesbian at Rutgers University.

Dr. Umpierre has also had another article, co-authored with Dr. Stekert, accepted for the May, 1992 issue of the <u>Cincinnati Romance Review</u>. The article has been lauded as a groundbreaking work in homosexual readings of literature. She and Dr. Stekert have been invited to the Fifth International Literature Congress, to be held at the University of Chile, in August of 1992 because of this important work.

Dr. Umpierre has also collaborated in writing the catalogue review for the one-person exhibit, in 1992 in California, of noted Mexican American Visual Artist, Santa Barraza.

Several of Umpierre's poems from her work-in-progress will appear in <u>The Américas</u>

Review, Fall 1991, including her pieces dedicated to Sylvia Plath and Elliott Gilbert. Her book review of <u>Teodoro Luna's Two Kisses</u> will also appear in the same issue.

Dr. Umpierre will be a Guest Writer at the University of Evansville and Clarion College in April of 1992.

"Who is Afraid of Isabel Allende?", Umpierre's previously "banned" essay, was read, by invitation, at the University of Miami in November of 1991, with the attendance and praise of Allende, herself.

Dr. Umpierre has created new courses on the Caribbean and Latin American Woman at Brockport, which will be offered for the first time in the Spring and Fall of 1992. In the Summer of 1992, she will offer a one-week intensive graduate seminar on Spanish American Women Writers for college, high school, and teachers in general. # Caribbean women tell stories of identity

Female writers in the Caribbean Third World have the multiple obstacles not only of sex but of racism, colonialism, poverty, Illiteracy, the imposition of Western religion, and the seemingly unshakable power of patriarchal institutions. It is from this complex fabric, this green cane curtain, that the women of the Caribbean have endured their mute generations.

This volume of 27 wildly disparate stories seeks not only to address this enforced silence but to make a statement about identity found at a brutal cost and forced into form, even if only temporarily. This is an eclectic assortment of short fictions, written in English or translated from

the Dutch, Spanish and French.

They originate in Trinidad and Jamaica, Puerto Rico and Cuba, the Dominican Republic, Haiti, Martinique, Guadeloupe, Surinam and Antigua. Their authors are as internationally known as Michelle Cliff, Jean Rhys and Jamaica Kincaid, or virtually unknown and never before available. And the stories they have produced are often stylistically unsettling, daring, bold to the point of deliberate sabotage, jarring and abrupt.

Here the folk tale, threads of oral tradi-

tion, verses from "The Arabian Nights," the Bible, the disco jukebox and clearly recognizable current political issues meet and mate. There are the fantastic lyrical juxtapositions of magical realism with the hard edge of standard parody. There is a fragmentary sense that these stories are not so much a potpourri as they are a puzzle of a collage slowly emerging from the mist of dream and the glaze across the jungle, under a riot of bougainvillea and orchids, of moonlight blazing across the petals of poinsettias and luminous geraniums, on nights of ripening mangoes, plantains and sudden domestic violence.

Of particular fascination is Cuban novelist and short-story writer Dora Alonso's "Cotton Candy," a tale of sexual obsession in which "butterflies were falling under the green whip, dying, astonished, and young Lola was gathering her fragile harvest to offer to her first love." Sometimes she walked hearing "the buzzing of the feverish beehives where she burned among the honey and the gyrations, wanting to sink her teeth into the sweetness full of stings." As an old woman, she finds the "inexpressible, contagious atmosphere . . . where the beasts became beautiful like the trees and the light."

Dominican-born Angela Hernandez's exquisite story, "How to Gather the Shadows of the Flowers," is a stylistically beautiful blend of poetry and psychology. A woman finds love in a personal and completely inhabited darkness of her own devising, where there are "violets and poppies growing deliriously, fennel and sunflowers and red-wine-colored hollyhocks

like open umbrellas." Finally, after asking repeatedly what is reality, our protagonist finds the solution: "Now I know how to irrigate a garden that won't stop growing, how to gather the shadows of the flowers, how to prevent their concealing the sun, and how to walk diagonally across the instants.

In these pages, the reader encounters a world of women without men, women who dig subsistence gardens for their children, wait for the fishing boats and embroider in solitude, or fly off to Miami or New York or Paris to become domestics in a land of granite and strangers where it snows and they do not know the language.

There are acts of sacrifice and courage, but that is merely a literal interpretation of the stories. They are, more accurately, about hallucination and mirage, multiple ocean crossings, exiles within exile, and how identity is accidentally created in an unexpected confluence of fate and will. This Caribbean is a region of amulets, of offering white rum to the gods, home remedies of herbs and potions and if that doesn't work, a priest or a psychiatrist. It is, despite the contradictions, somehow a pragmatic world.

There is a cumulative power to this volume, to these tales of migration, and the hunger for food, love, knowledge and power. Ultimately, these are stories about the struggle for transformation and what is most memorable and haunting, the sense of women daring to reveal themselves as passionate and vulnerable in the act of giving
