Algeo, Katie (In Development) Mammoth Cave and the Making of Place: A Cultural History. - Book

This book uses an in-depth case study of Mammoth Cave, Kentucky, to explore the power of cultural values to transform the land. It traces the region's development through industrial and private tourism phases before it was designated a national park and reconstructed as a wilderness landscape. Mammoth Cave was one of America's least likely national parks because of a long history of human use during the modern era and because it did not conform to the internationally recognized national park model established by the earliest parks, such as Yosemite and Yellowstone. By focusing on the motivations and actions of individuals instrumental at each stage of Mammoth Cave's history, as well as the business, non-profit, and government institutions through which they worked, the project reveals how cultural values are inscribed on the land and the power of ideology to profoundly and materially transform our world.

Each of the following articles presents research that I have done to understand specific aspects of Mammoth Cave's cultural history. The individual articles allow topics to be explored at greater length than the book can accommodate. Each will be submitted to a peer-reviewed publication.
