Purpose of Course: MATH 183 students will learn to interpret, illustrate, and communicate mathematical and statistical ideas. Further, students will learn to model and solve problems. As part of this course students will learn concepts from introduction to elementary probability theory; the analysis of data by means of frequency distributions and the statistics which describe them; the binomial and normal probability distributions; statistical inference; and emphasis is on applied real world problems. This course is not accepted for credit toward the mathematics major or minor.

Learning Objectives: MATH 183 specifically meets the following five learning objectives as part of the Colonnade requirement for quantitative reasoning.

- 1. Interpret information presented in mathematical and/or statistical forms.
- 2. Illustrate and communicate mathematical and/or statistical information symbolically, visually and/or numerically.
- 3. Determine when computations are needed and execute the appropriate computations.
- 4. Apply an appropriate model to the problem to be solved.
- 5. Make inferences, evaluate assumptions, and assess limitations in estimation modeling and/or statistical analysis.

Prerequisite: Eligibility for College Algebra based on Math ACT, MPE, COMPASS, or KYOTE scores; or DMA 096 C with grade of C or better.

Attendance Policy: Registration in a course obligates the student to be regular and punctual in class attendance. Four or more unexcused absences from class may result in an "F" as final course grade. A student absent from class bears full responsibility for subject matter and announcements missed.

Testing and Grading: Students are responsible for material presented in class and the material in the text. There will be 100 points of homework, assigned and graded regularly using MyLabStat, Three 100-point tests, and a 150-point comprehensive final exam. There may be up to 50 points of additional daily grades, consisting of homework, quizzes, or projects. Grading will follow the 10-point scale. The final exam will be given at 10:30 Tuesday, December 3, 2024.

Course Materials: You will need a TI-84 calculator. (A TI-83 might work, but all instructions will be for the TI-84.)
